

# Danné Montague-King Client Information Form

Congratulations on your choice to have one of our skin treatments. These procedures are results orientated and are designed to change and improve skin conditions. These are not invasive Treatments, more so we are using the body's chemistry to induce a result. We do not peel skin we use hydrolyzation, which turns dead protein cells, not the living cells into a weak acid to be flushed from the skin. DMK treatments are safe for all skin categories and races, Results may vary from person to person.

You have the right to be informed about your DMK professional treatment and its aftercare.

### ALKALINE WASH

Alkaline Wash is designed to abort the surface epidermal cells of the skin, dissolve hair, soften tissue and assist in excreting dead and dying cells. The series of treatments prescribed by a qualified technician gives a similar effect as a chemical peel without the trauma of a controlled burn or the uncomfortable convalescence required by conventional medical peels.

I understand the above description to Alkaline Wash.

I understand and agree to the following:

1. While Alkaline Wash treatment will give a definite improvement and restoration of health to my skin, topical chemistry, like surgery, is not an exact science. Therefore my skin therapist performing this procedure cannot guarantee the exact results or a time frame in which optimum results may be achieved. They can only offer testimony to past cases including any before and after photo's a prior client may wish to release for viewing.

2. While Alkaline Wash is usually accompanied by minimum discomfort provided I follow the home prescriptives given to me by my technician faithfully. I may experience the following:

- Redness and a slight sandpaper effect on the skin
- Peeling proceeded by a crusty hardness to the skins surface
- Irritation around the eyes and the mouth area and sometimes on the chin

- An outbreak of pimples, gases and other impurities that were already present in the skin.
- A slight burning sensation or "sunburn" sensation in the early stages of the treatment.
- An irritated, open lesion that may weep and then scab and heal normally (requires antibiotic gel as prescribed by physician of therapist).

#### ALKALINE WASH HAIR REMOVAL

- 1. I understand that Alkaline Wash hair removal treatments may not be permanent in my case.
- 2. I understand that Alkaline Wash does not affect the growth rate or shock the hair into delaying growth rate as in the case of waxing.
- 3. I understand that I am getting the added benefit of exfoliation as well as hair removal at the same time.
- 4. I understand that Alkaline Wash treatments will weaken my excess hair, not encourage more growth or coarsen my hair.
- 5. I understand that in as much as Alkaline Wash is a professional treatment formula the chances of me suffering any permanent skin damage from the treatment are practically non-existent.

## ENZYME TREATMENTS

Our enzyme blends contain anti-itch ingredients and inhibitors of allergic reactions, reactions are very rare.

Things that you may experience After Enzyme treatment:

Break-outs, we cannot cause any breakouts to occur, however if there is congestion or trapped sebum plugs the treatment may release these from the epidermis and result in a superficial break out.

Dry, tight patches – this is where dead protein cells are still attached to the epidermis and has not been released.

If there is underlying pigment due to the aging process, it may cause this to move to the surface. This is due to the hydrolyzation of dead protein cells. Making the area look more visible to the eye.

Redness, heat and a slightly stingy sensation for the first or second day (more so on the stronger treatments).

We are activating the skin to function normally so it may feel different (as in different texture) whilst undergoing treatment.

I understand these contraindications are temporary and often accompany a successful treatment over a period of time.

Should none of the above contraindications occur, I understand that this is not a sign the treatment is not working but rather I am in excellent health and respond to organic material well.

## PRO ALPHA SIX-LAYER PEEL

The DMK Pro Alpha Six-Layer Peel treatment uses a combination alpha hydroxy acids designed to remove the surface epidermal cells of the skin. This treatment has been designed to be extremely effective in reducing wrinkles, light scarring, and uneven skin tones with limited discomfort, contraindications, or convalescence. This treatment is safe for use on all skin types and will be adjusted in strength to your particular skin type and level of sensitivity.

1. You should have at least one or two Danné Enzyme Treatments before having a Pro Alpha Six Layer peel treatment.

2. One week before your scheduled the Pro Alpha Six-Layer Peel Treatment. You will notice that while using the Retosin, your skin will begin to look leathery and darker this is normal.

3. On the day of your Pro Alpha Six-Layer Peel Treatment, your practitioner will begin applying six separate layers of the Pro Alpha Serum. You will experience some stinging and burning during these applications, these sensations will subside. If the irritation becomes too uncomfortable, let your practitioner know so that your serum can be adjusted for further application.

4. After the application is completed, you will leave the serum of your skin and will not wash for at least 12 hours. Your skin will look shiny and may be slightly red. If your skin continues to burn, rinse with a solution of baking soda and water.

5. In the event that you experience and blisters, sores or weeping of the skin, contact your practitioner and begin applying a topical anti-bacterial salve to prevent any possibility of infection.

6. Beginning the next day, you can start cleansing your skin as normal with your DMK cleanser followed by a small amount of Acu Crème or Contraderm as prescribed. You must apply sunblock if you are going to have any exposure to the sun. Should you choose, you can also start using make-up as desired.

7. By the third day, you should begin to notice your skin beginning to peel. This will vary depending on your skin type from minor flaking to large peeling sections. Regardless of how severe the peeling is, you must not pull, pick, or scratch at the dead skin. It is very important that you allow this skin to come off naturally.

8. By the seventh day, most of this dead skin will have exfoliated (detached) itself from the healthy new cells below. On this day, you will be scheduled for an Enzyme Lift-Off Treatment. This treatment helps remove any remaining dead cells that have not completely exfoliated.

9. You must now use your regular Danné Home Prescriptives and continue with your professional maintenance treatments in order to maintain your results.

Note: This treatment will give definite improvement and restoration to the appearance of your skin. However, each individual's result will vary depending on their skin condition and skin type. While many will be satisfied with just one treatment, others may require several treatments over a period of time to achieve their desired results.

Although this treatment is safe for all skin types with minimum contraindications, it is possible that you may experience some of the following temporary contraindications as a result of this treatment.

- Stinging and burning sensation to the skin
- Redness and irritation of the skin
- Swelling or tightness of the skin
- Blistering, weeping or scabbing of the skin. If this occurs, notify your practitioner and begin using an antibacterial salve to avoid possible infection.
- Outbreak of pimples if impurities have been locked under the skin
- Excessive peeling of the skin
- Darkened colour of the skin until it exfoliates
- Increased photosensitivity of the skin, avoid problems by using sunblock

Although these contraindications may be uncomfortable, they will not result in any permanent damage as long as you inform your practitioner of any problems and follow instructions you are given. As with any treatment, there is always a very small possibility that you could have a negative reaction that you practitioner could not predict.

Should none of the above contraindications occur,

I understand that this is not a sign the treatment is not working but rather I am in excellent health and respond to organic material well. Results will vary from person to person since each individuals skin is different.
